We, the undersigned parents/guardian of _____ (Child) hereby consent to the Child's enrollment in MBGA Summer Golf Camps and acknowledge and agree as follows:

1. I/We understand that the Child will participate in the sport/game of golf while attending the Mike Bender Golf Academy Summer Golf Camps. I/We understand that these activities will involve physical exertion by the Child as well as contact with other children and instructors attending the Mike Bender Golf Academy Summer Golf Camps, and that many of the activities will take place outdoors.
2. While attending the Mike Bender Golf Academy Summer Golf Camps, the Child will be transported by golf cart while at the golf course and facilities operated by the Mike Bender Golf Academy.
3. I/We understand that all possible precautions are taken to assure that the programs and activities are conducted by mature and qualified personnel in a safe and responsible manner. However, because of the nature of some activities, I/We understand that there is a potential for accidental injury to the Child regardless of the degree of supervision. I/We do recognize these risks and allow the Child to participate in the activities of the Mike Bender Golf Academy Summer Golf Camps, and as a material inducement to Mike Bender Golf Academy and all successors, assigns, affiliates, partners, co-venturers, shareholders, directors, officers, employees, and assigned coaches of the foregoing (all of the foregoing are hereinafter referred to as "MBGA and its Affiliates"), from and against any and all manner of actions, causes of action, controversies, agreements, promises, damages, rights, injuries, judgements, executions, claims, and demands of any nature whatsoever in law or in equity, that I/We or the Child may have now or in the future, for or by reason of the Child's participation in Mike Bender Golf Academy's Summer Golf Camps, including, without limitation, claims or liabilities asserted for the Child's injuries while participating in any act during said Mike Bender Golf Academy Summer Golf Camps, unless such injury is directly caused by the negligence of Mike Bender Golf Academy or any Mike Bender Golf Academy employee/golf instructor acting within the scope of such employee's/instructor's authority.

I/We, the undersigned, agree to save, defend, indemnify, and hold "MBGA and its Affiliates" harmless, from and against any and all manner of actions, causes of action, controversies, agreements, promises, damages, injuries, rights, judgements, executions, claims, and demands of any nature whatsoever, in law or in equity, that are or may be asserted, entered or claimed against "MBGA and its Affiliates" or any of them by any person or entity, for or by reason of the Child's acts, negligence, willful misconduct or omissions to act, while attending the Mike Bender Golf Academy Summer Golf Camps or participating in any activities as part of the Mike Bender Golf Academy Summer Golf Camps.
5. The undersigned are not aware of any behavioral or psychological problems, or medical or physical limitations, of the Child.
6. In case of emergency, Mike Bender Golf Academy is authorized to seek medical treatment and transportation for the Child from such physicians, hospitals, and ambulance services as may be chosen by it in its reasonable discretion.
